HOSPITAL FEES

If you are insured under the The Ontario Health Insurance Plan (OHIP), the majority of costs incurred as a result of your stay at Runnymede Healthcare Centre will be covered by this insurance. However, there are costs that are associated with your stay that are not covered by OHIP and are billed to the patient directly. As a courtesy to our patients, we offer direct billing to insurance providers. While we facilitate this service for convenience, the ultimate responsibility for payment remains with the patient. In the event that an insurance provider does not cover the full cost of treatment, patients are responsible for any remaining balance.

These costs include:

- Co-payment (if applicable)
- Preferred accommodation
- Bed holding
- Transportation for non-emergency and/or medical appointments
- TV, web, laundry and footcare services

CO-PAYMENT

Patients admitted to complex continuing care programs in Ontario are charged co-payment fees, which help cover non-medical costs like meals and accommodation during long hospital stays. Co-payment does not apply to High Tolerance Short Duration Rehabilitation and Low Tolerance Long Duration Rehabilitation patients.

Co-payment fees are set by the Ministry of Health and Long-Term Care (MOHLTC), but are not a form of government revenue; instead they go directly to our hospital and are essential for supporting an outstanding patient experience.

If it applies, the co-payment fee charged to a patient is based on their income level.

PREFERRED ACCOMMODATION

If you request and are given a semi-private or private room, you will be billed for the room at the appropriate room rate. Billing starts on the admission date.

Daily room rates for our Medically Complex (MC), Low Tolerance Long Duration (LTLTD) Rehabilitation, and High Tolerance Short Duration (HTSD) Rehabilitation programs are as follows:

TRANSPORTATION FOR NON-EMERGENCY AND/OR MEDICAL APPOINTMENTS

Patients are responsible for paying for external medical or personal appointments as well as any associated transportation costs. If you require an escort and do not have someone to accompany you, Runnymede will provide an escort at the patient's expense.



TV, WEB, LAUNDRY AND FOOTCARE SERVICES

Runnymede has TV, web, laundry and footcare services available for patients who would like to purchase them. The rates per program are as follows:
